**NOTICE FROM THE GRENADA AUTHORITY FOR THE REGULATION OF
FINANCIAL INSTITUTIONS (GARFIN)**

In accordance with Section 140 (2) of the Insurance Act Cap. 150 of 1973, the general public is hereby informed that as at April 15, 2010, the under-mentioned Insurance Companies, Association of Underwriters and Intermediaries (Brokers, Agents, Sub-Agents and Salespersons) were registered under the Insurance Act to operate in Grenada for the year ended December 31, 2010.

The public is advised that Certificates of Registration are issued to all companies and intermediaries authorized to conduct business under the Insurance Act. Section 72 (1) of the Insurance Act requires all persons duly registered under the Act to produce their Certificate for inspection if requested by any person dealing in the course of business.

The assistance of the public is solicited in bringing to the attention of GARFIN any person or institution conducting insurance business in Grenada without a current license.

The public is further advised that Mc. Intyre Brothers Limited is no longer authorized to conduct business as an insurance agent for Island Heritage Insurance Company Limited or any other insurance company.
